J. REUBEN CLARK

J. Reuben Clark, a graduate of the Columbia University Law School, was a distinguished lawyer who spent most of his career in public service holding such positions as Solicitor of the State Department, Under Secretary of State, and eventually as Ambassador to Mexico, During World War I he was a major in the Judge Advocate General's Officers' Reserve Corps, and served for a time while on active duty in the U.S. Attoriety General's office preparing emergency legislation on the war powers of the President, He was awarded the Distinguished Service Medal. He spent the last 28 years of his life as a member of the First Presidency of The Church of Jesus Christ of Latter-day Saints.

THE Rex Lee ADVOCACY AWARD

The Rex Lee Advocacy Award is presented annually to one of the nation's outstanding advocates whose life and legal practice reflect the values exemplified by the award's namesake. Rex Lee, a former U.S. Solictor General, university president, and founding dean of the BVU law school. The National Law Journal has called the Award a "coveted" prize with an "honor roll. that reads like a who's who among the nation's top appellate lawyers."

Rex Lee was a distinguished appellate lawyer who argued 59 cases before the United States Supreme Court. Shawn Bentley, a graduate of the University of Cicago Law School, spent over a decade working for the United States Senate, eventually becoming the Deputy Chief Coursel for this Senate Judiciancy Committee. He helped write a number of Important pieces of legislation, including the He helped write a number of Important pieces of legislation, including the Protection Act. After Issuing the Senate, he worked as Vices President Protection Act. After Issuing the Senate, he worked as Vices President of Intellectual Property and Global Public Policy for Time Warner. At the time of his passing, Senator Orrin Hatch paid tribute to Shawn on the Senate (floor, saying, "Shawn was among the brightest and most informed Vet, he was never arrogant, a rare quality in one so talented, especially on Capitol Hill. — And it was such a loy to work with him, because all knew he was a model of decency, humility, and spirituality."




